- The deadline to register your vehicle for a parking decal has passed. Any car that is parked for longer than 24-48 that does not have a decal will be towed at the owners expense.



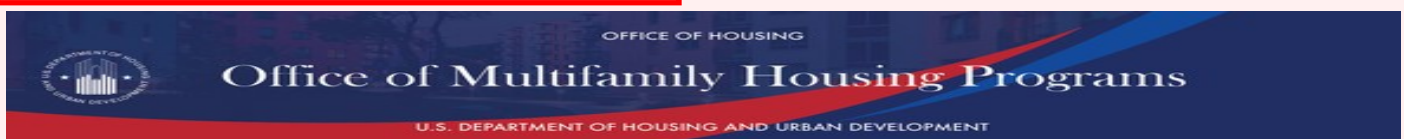
Tenant Talk with Erika

HUD Multifamily Project-Based Rental Assistance Programs Remain Operational

The U.S. Department of Housing and Urban Development (HUD) has confirmed with the Office of Management and Budget (OMB) that all rental assistance payments for all Multifamily project-based rental assistance programs **remain operational** and are not subject to the pause in federal grants and loans outlined in OMB's memo to federal agencies yesterday. HUD's Office of Multifamily Housing Programs will continue to meet its project-based rental assistance financial obligations to owners and tenants participating in these programs.

THREE RIVERS REGIONAL COMMISSION TRANSIT PROGRAM

The Three Rivers Regional Commission Transit Program is operated by the agency (also known as Three Rivers Transit) using a “Demand Response” model, which allows the transit bus to pick up consumers from their residence and drop off at the requested destination. The area of operation includes the following counties:

TRRC Transit Program	\$2.00 Fare One Way	Butts, Lamar, Pike, Spalding, and Upson Counties
Carroll Connection	\$3.00 Fare One Way	Carroll County
Meriwether County Transit Program	\$3.00 Fare One Way \$10.00 Fare Out of County	Meriwether County (and select cities outside of the county)

Hours of Operations: 8:00 AM until 5:00 PM, with the last ride pick up scheduled for 4:30 PM

Days of Operations: Monday thru Friday
