Attention All Parents:

Settings for Air Condition Units:

Summer is coming to a close, but the hot weather will linger behind just a little bit longer. We advise all tenants to not set your AC unit below 73 degrees. On days where temps are 100 plus degrees, setting your temp below will cause the unit not to work properly, and/or freeze up, causing it to not work at all.
